#### A. **30<sup>th</sup> Street Pipeline Replacement Project Update** (6:15-6:35pm)

The 30<sup>th</sup> Street Pipeline Replacement Project will replace approximately 5.7 miles of water main within the North Park, Golden Hill, and Southeastern communities. This project will also increase pedestrian access by installing curb ramps at several intersections throughout the project area. Construction scheduled through July 2020. Jaime Ramos Banuelos, Project Manager.

#### Presentation Highlights

Presenters: Teddy/Nick /Jaime

- 5.7 miles of water pipeline replacement along 30<sup>th</sup> Street from Polk to Commercial Street
- Resurfacing streets, adding curb ramps
- Construction started 4 months ago. Will continue for 2+ more years
- Water outages will have notifications in advance to those impacted. Notifications will include door hangers and posted signs that will include contact info.
- Longer outages will have temporary water lines. No fire water service available during these times.
- Ortiz Consturction is the contractor. Large excavation equipment will move along with construction. It will be parked on side streets as much as possible to lessen impact on parking and businesses.

## Discussion

- Will repaving include bike lane striping? There is outreach to Chris Wards office and plan is to try to get upgraded bike lanes through the City. NPPC should weigh in to help with efforts.
- Any areas that are not bikeable should be sent to the contractor for immediate repair/improvement until final repaving occurs.
- Will bus routes be impacted? Yes, there are MTS procedures to re-route bus routes and post notifications at impacted bus stops.

## **B. Howard Ave. & Robinson Ave. Bikeways – Project Updates (6:35-6:55pm)**

Updates on the Howard Bikeway, Robinson Bikeway, and Project Aesthetics Questionnaire for the North Park/Mid-City Bikeways. Alison Moss, Project Manager, SANDAG.

### Presentation Highlights

- Howard Ave bikeway goes from Park Ave to 32<sup>nd</sup> Street
- Buffered bike lanes will be created by removing center turn lane on Howard Ave.
- Speed control design at specific intersections (traffic circles, bend outs)
- Cleared CEQA on 2/16/18
- Final design extends through 2019 with complete plans to SD Development Services Dept in 2019. Construction in 2020 to 2021
- Robinson Street project is in final design, survey and geotechnical studies are completed. Construction will also be 2020, same as Howard Ave
- Aesthetics Questionnaire: hardscape and landscape preferences – see presentation. Continue to work with City to incorporate community preferences per the questionnaire results.

## Discussion

- Bonn: opposes taking out parking spaces along Howard Ave near Park Ave by the Sprouts. Would like to add angled parking on Georgia.
- Doster: undergrounding utilities on Howard Ave will end in August/September of 2019. Bikeway construction begins sometime in 2020. Don't want to repave Howard Ave twice. Moss: Coordinating with undergrounding project manager. Undergrounding project does not involve repaving entire street. They will repair street to good condition. Howard Ave will be repaved during bikeway project.
- Community:
  - Will plans include space for scooters and shared bikes to be parked? No
  - How long does design review take? Usually 6 months but taking longer for these projects due to innovative design features. Plans are final once they go to City other than changes required by the City.
