- c) Approval of Previous Meeting's Minutes: January 9, 2019 **Hill/Vidales 5-0-2 (Velasquez and Gebreselassie abstained due to not being present at the meeting)**
- d) Announcements
 - a. Bonn: Councilperson Ward mentioned comfort station for Trolley Barn Park. This is opposed by UHCA
 - b. Vidales: Voice of San Diego article reported Plaza de Panama project is on hold due to increased construction costs.
 - c. Wilde: NPPC Board elections will be held at the March meeting.

A. Mission Valley Community Plan Update DRAFT PEIR (6:15-6:45pm)

The Mission Valley Community Plan update includes widening Texas St. north of Madison Ave., as well as cross streets, to mitigate traffic impacts in North Park. See pages 426 and 428 of the PDF in the PEIR: https://www.sandiego.gov/sites/default/files/compiled_deir-compressed.pdf

Discussion

Doster: Opposes widening of Texas Street. Cars speed down Texas Street into Mission Valley and many cars drive in the bike lane.

Wilde: Opposes widening of Texas Street and in favor of protected bike lanes down the hill into Mission Valley.

Gebreselassie: Traffic lights need coordination on Qualcomm/Texas Street crossing I-8. Extra width of road would be better utilized for bike lanes.

Bonn: Texas Street shouldn't be four lanes. It would impact residential area. A parking curfew could be implemented along Texas at certain times.

Hill: Mission Valley Community Plan proposes worst-case scenario covered in the North Park Community Plan. Focus should be on Texas Street between Madison Avenue and South Camino del Reina.

Vidales: Opportunity to state support for protected bike lanes and lighting on Texas Street. Does not support Texas Street widening. There is the new historic district Melhon & Son, parking will be lost, and this is a residential area.

Velasquez: Opposes widening of Texas Street. Read letter from Marissa Tucker stating opposition to the widening of Texas Street.

Public comments:

- Should reduce speed from 40 mph to 25 mph. Opposed to widening.

SUBCOMMITTEE MOTION 1:

To support adding the following improvements on the east side of Texas St. from Camino Del Rio South to Madison Avenue: (1) Physically protected bike lane; (2) Sidewalk; (3) Acorn style lighting to match the west side of Texas St.; (4) Pedestrian guard rail.

Vidales/Hill 7-0-0.

SUBCOMMITTEE MOTION 2:

To oppose widening Texas St. from Camino Del Rio South to El Cajon Boulevard. The segment Texas St. from El Cajon Blvd. to Madison Ave. has single family homes with driveways, and it includes the recently designated “Melhorn and Son” Historic District. The outdated methodology of Level of Service (LOS) should not be the only methodology used to determine transportation impacts, and other methods should be used such as Vehicle Miles Traveled (VMT). The following recommendations are made: (1) The synchronization of traffic lights north of Camino Del Rio South would improve traffic flow; (2) Adding protected bike lanes from Camino Del Rio South to Friars Road would improve bicycle utilization; (3) adding a northbound right turn lane at Texas St. and Camino Del Rio South would improve traffic flow.
