II. Non-Agenda Public Comment (6:05-6:10 p.m.)

- a. Limited to Items not on Agenda; non-debatable. Two-minute maximum, Chair can award more time.
 - i. Comments provided on Councilman Whitburn's F25 budget recommendations and emphasis on funding for homeless, but there was no mention of low income or affordable housing
 - ii. Lynn mentioned upcoming event on 27 Oct at North Park Mini-park

III. Action and Informational Items (6:10-6:55 p.m.)

- a. Informational Item 1: Discuss recommendations to improve traffic and pedestrian safety at the intersection of 30th, Upas and Ray Streets
 - i. Comment that emergency vehicles and buses must encroach on opposite traffic lanes while passing through this intersection.
 - ii. Comment regarding the true issues at this intersection, and suggestion to review any data of incidents in order to help determine what an effective solution may be.

- iii. Comment that it is a very dark intersection at night, and that better lighting would be an improvement
- iv. In addition to the named street intersections, the exit from the adjacent Jack-In-The-Box drive-through also feeds into this intersection, recommend altering traffic flow from this exit
- v. Request a traffic engineer or appropriate expertise from the city to review this intersection and to assist in proposing effective solutions
- b. Informational Item 2: Review North Park Community's CIP Priority List (List compiled from North Park Community Plan, 2021 CIP, 2023 Survey, and other sources)
 - i. The ad-hoc committee stood up at the last subcommittee meeting (Doug, Lynn, Liz) met and reviewed inputs to the 2023 CIP priority list. Items that had already received attention, were better reviewed by a different body i.e. Balboa Park, or items better suited for a "Get it Done" web app submission were removed from the list. Nine items were reviewed, and seven were recommended as submissions to be reviewed at the next full NPPC meeting.
